Binding Effect. This instrument shall be binding upon me, my relatives, personal representatives, heirs, beneficiaries, next of kin, and assigns and shall inure to the benefit of THE AMERICAN ROYAL, its employees, agents, and representatives and CELEBRITY SALES LLC, its members, managers, employees, agents, and representatives.
